Wild Mountain Music Festival, July 20, 21 & 22, 2012

Thank you for your interest in having a Food Concession at our festival. We are anticipating a great year as we celebrate our 5th Annual event.

Conditions at the festival are 'rustic'. We do not have running water, power or a bank machine. Please leave your pets and ATVs at home. We provide the ground space and generator power. Vendors need to bring everything else necessary to have a successful and comfortable weekend : **drinking and cooking water**, food prep equipment, booth or trailer, hand and food washing stations, extension cords, power bars, garbage cans, lighting, etc.

We expect about 2,500+ people pass to through the gates over the course of the weekend. Although vendors determine their own hours of operation, booths must remain open for the duration of the festival. All vehicles brought onsite require a vendor pass

Public Health department requirements for temporary food establishments must be adhered to. It is the vendor's responsibility to know these regulations.
